Payment for Services: A non-refundable retainer of 50% of the total package amount is due at the signing of this agreement. Upon receipt of this payment, *Chris Fessler Photography* will reserve the aforementioned ceremony date, and be available for you on this date. The retainer will be applied to your total amount due. The final payment of the remaining balance is due 10 days prior to the ceremony. If services are retained less than 10 days prior to the ceremony, the full balance will be due at signing. If the total balance is not fulfilled prior to 10 days before the ceremony, we reserve the right not to photograph the event with a forfeiture of the retainer. If the planned ceremony is rescheduled to a date in which *Chris Fessler Photography* is not available, for any reason, the client will forfeit their retainer. If the planned ceremony is cancelled for any reason, the client will forfeit their retainer.

Limits of Liability: While every reasonable effort will be made to provide the highest quality photographs of the ceremony, the entire liability of *Chris Fessler Photography* to the client for any loss of photographs due to equipment malfunction or failure is limited to a refund to the client of the amount paid for services. Because a wedding is an uncontrolled event, *Chris Fessler Photography* cannot guarantee delivery of any specifically requested image(s). *Chris Fessler Photography* will not be held liable for the finished product or incomplete coverage in the event of tardiness, time restrictions, and/or constraints placed on the photographers by the client or any outside vendors, including clergy or church restrictions and/or policies. In the unlikely event of personal illness or other circumstances beyond the control of *Chris Fessler Photography*, a substitute photographer may be recommended to fulfill the obligations of the contracted event. In such case that a substitute photographer is not recommended, or the client denies the recommended substitute photographer, the limit of liability on *Chris Fessler Photography* is a full refund of all monies paid by the client. If for any reason the client is unsatisfied with the images from the contracted event, the contracting party is to immediately make *Chris Fessler Photography* aware after initially viewing their online proof gallery, but before receiving their disc. The client will then have two options: 1) The client can choose a refund of monies paid, less the deposit, and forfeit the right to receive all products included in their purchase, both physical and intellectual, including, but not limited to the disc of images from the contracted event and their rights to the images. 2) The client can choose to receive the contents of their purchase, but are not entitled to a refund of any monies paid.

Permissions: It is the client's responsibility to schedule and receive permission to use any locations related to the contracted event for photography, including the wedding and reception locations.

Products: While every effort will be made to have the purchased products (digital images, disc(s), book(s), print(s)) delivered within sixty days from the wedding date, it may take longer in some cases. The client will be notified in a timely manner if any delays are expected. Due to the aspect ratio of different sized photographic prints, any printed photographs may vary slightly in composition than the digital image provided in the online proof gallery.

Release: *Chris Fessler Photography* has permission to use all images obtained during the contracted event for portfolios, samples, reviews, and self promotion purposes.

Copyright: Digital images created by *Chris Fessler Photography* as related to the event that the client has contracted for will become the property of the client upon transmission of the digital images from *Chris Fessler Photography* to the client in file form on a compact disc or DVD. Until the point of this transmission, ownership will remain with *Chris Fessler Photography*, with all rights therein implied.
